

## **General Information** Accommodations

The headquarters for the annual conference of the National Association of State Treasurers is the Grove Park Inn, located at 290 Macon Avenue, Asheville, North Carolina 28804-3799. The special conference room rate is \$240 plus 11% state and occupancy taxes. The deadline for making your reservations is **September 4, 2013.** Please make your hotel reservation well in advance, because rooms will sell out quickly during peak tourism season.

Make your reservations directly with the hotel by calling (800) 438-5800 or online at www.groveparkinn.com. The group code for NAST reservations is 1004798. A deposit of one night's accommodation and state sales tax is required at the time your reservation is made. Deposits are refundable up to 72 hours prior to 4:00 p.m. on the date of your scheduled arrival. A \$75 penalty will be charged if you check out prior to your scheduled departure date. The check-in time is 4:00 p.m., and check-out time is 11:00 a.m.

## **Travel Information**

The Asheville Regional Airport (AVL) is 17 miles and a 20-minute drive to the hotel. This nearest airport is served with daily flights by the following airlines: Allegiant, Delta, United, and US Airways. Taxi service to the hotel costs approximately \$45 each way.

Additional flights are available through the Greenville-Spartanburg International Airport (GSP) and the Tri-Cities Regional Airport (TRI), which are each approximately 60 miles and 70 minutes away.

### Attire

Business casual attire is appropriate for all conference sessions and social events. The average temperature in Asheville for this time of year ranges from a high of 74 to a low of 50 degrees. Be sure to pack a sweater or light jacket for evening activities.
