8:45-10:15 am: Part 1 - ABLE Legislation and Regulation – How Both Impact Your State's ABLE Plan Today and Into Tomorrow

Experts will educate attendees on the history, viewpoints and possible hurdles of current NAST legislative ABLE priorities described below, which were ranked by respondents to the September NAST Survey. Information will inform states as 2020 legislative priorities are set.

- Medicaid Recovery, Multiple Account Ownership and Successor Beneficiaries -Each has been identified as having potential to expand enrollment. ABLE Plan administrators need a better understanding of what they are and the potential hurdles to legislation.
- Lump Sum Contributions: Allow lump sum contributions in certain circumstances, such as insurance settlements, small inheritances, etc. Some disability advocates say that this could be a positive incremental next step for ABLE.
- Employer contribution tax incentive: Establish mechanism for employers to contribute to an employee's ABLE account. There may be more interest by employers on this one.
 ABLE could lead the way on this one.

Attendees will be educated about the role of the Social Security representative payee (SSRP) and of the authorized legal representative (ALR) and will have clarity on whether and how the ALR can be expanded to include SSRPs through legislation, administration or both.
