



Appendix D: Top Certifications for Public Finance Roles

Across all public finance roles analyzed within this report, employers are most frequently requesting that their employees be Certified Public Accountants (<u>CPA</u>). The next most frequent certification is the Certified Government Financial Manager (<u>CGFM</u>), followed closely by Project Management Certification and Certified Internal Auditor (<u>CIA</u>).
