## FAQS

- 12-week pilot program launched in March 2025
- Designated employees in 2 divisions working with public information
- Weekly check-ins/Training sessions with OpenAI engineers
- Third party analyzing results



## Purpose: Increase efficiency and modernize state government

### Challenges:

- Buy-in from employees
- Concerns over accuracy
- Safety of private information
- Concern over eventual job replacement

### Results:

- Operational efficiencies in both divisions involved in pilot program
- UPD potentially finding millions of dollars in unclaimed property
- SLGFD staff estimates 5 hours per person per week saved in administrative work

### Takeaways:

Consistent messaging from leadership – combined with support and clear goals – allows for adaptation of “new way of doing things” to the benefit of the people of North Carolina

“It’s rewarding when ChatGPT produces results that enables you to succeed in your job of serving the citizens of N.C. in a more efficient manner”

## Unclaimed Property Division

**Initial Plan:** Increase speed at which UPD could identify and contact property owners

**Pivot:** Focus on compliance

- Identify types of companies that may have property/ and identify companies that meet profile in N.C.

**Result:** Typical 10,20,30 searches reduced to one – done instantly

## State and Local Government Finance Division

**Initial Plan:** Increase speed of audit reviews for 1100 local government units in the state

**Pivot:** Research, memos and communication to entities across the state

**Result:** Legwork accelerated to keep things moving at an overall faster pace – hours saved per employee each week

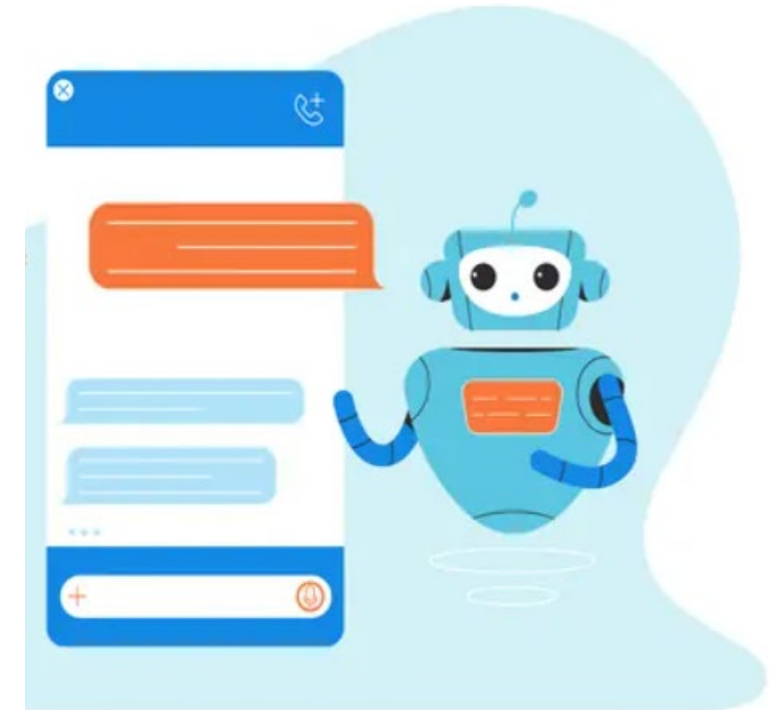

It sounds like OneNote is automatically converting the letter "e" in parentheses—like (e)—into the euro symbol (€). This is a known autocorrect behavior in Microsoft Office apps, where certain character combinations are replaced with symbols. Here's how to fix it:

1. Open OneNote
2. Go to File Options
3. Select Proofing from the left-hand menu
4. Click Auto Correct Options In the AutoCorrect tab
5. Look for the entry that replaces (e) with € Select it and click Delete

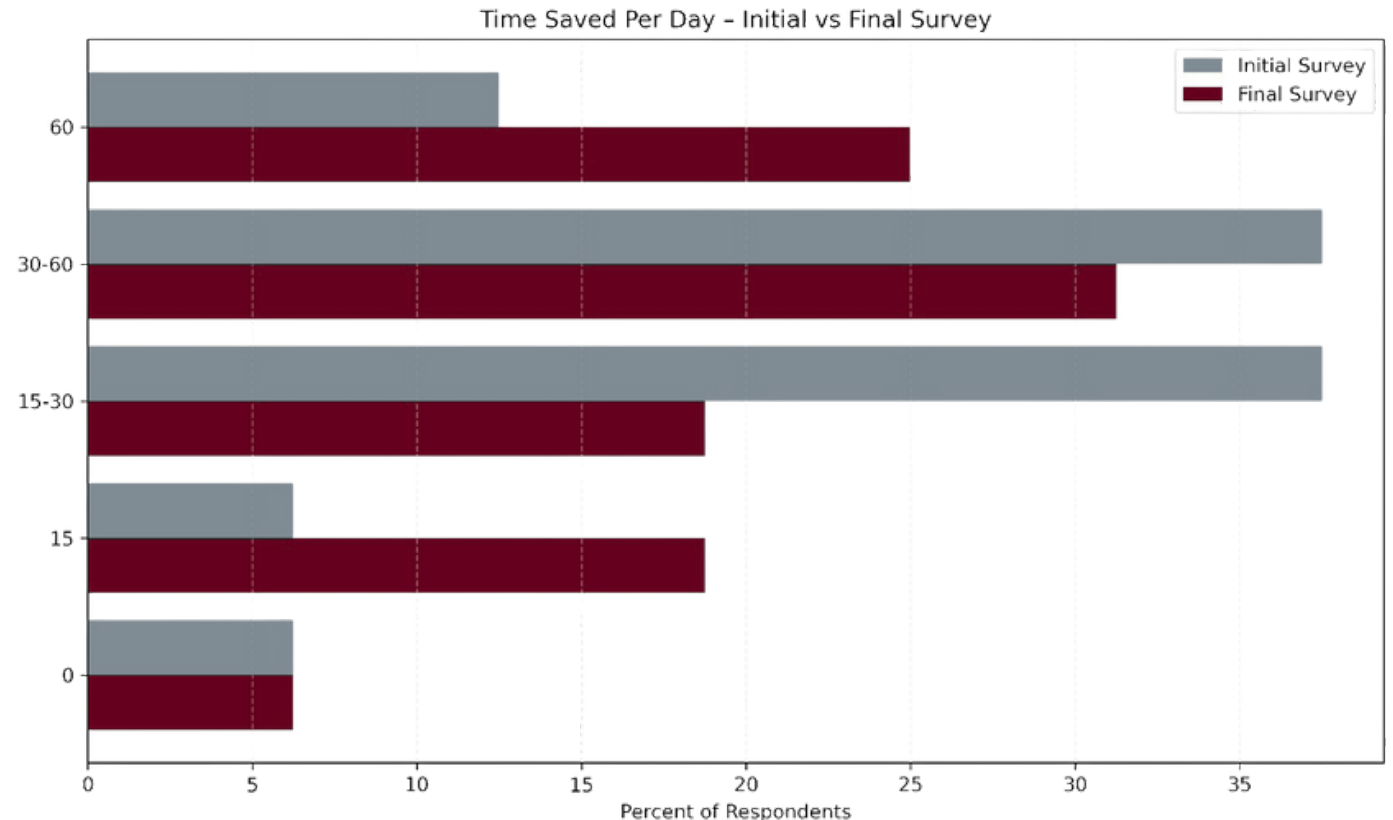
# Employees' Most Helpful Use Cases
